## 49.9% of shareholders elect to reinvest 100% of their 2016 dividend in shares

The Shareholders' Meeting which was held on May 5 2017 decided to pay a dividend of 1.05 euro per share, with each shareholder given the option of reinvesting 100% of the dividend in shares at a price of 37.16 euros, taking into account a 5% discount. The dividend was paid on Tuesday June 6.

Shareholders who elected to reinvest 100% of their dividend in new shares hold more than 49.9% of the Company's capital on aggregate, which is an expression of their confidence in Accor's strategy and prospects. The stock dividend involved the issue of 3,975,968 new shares, representing 1.39% of the Company's capital. These shares carry dividend rights from January 1, 2017.

The cash dividend paid today represents a cash payment of around 150 million euros.
